Leslie Williams has received several threatening or harassing phone calls from December of 2014 to February of 2015. No messages have been received since February 6th, 2015.

ORIGIN:

Officer Willkomm #5929 and I were working the front counter at 202 C Street, the City Administration Building when Williams approached us.

INVESTIGATION:

Williams is a regular at City Hall. I have spoke with Williams about several topics over the years. Today Williams was there to get a report for threats made to her on her cellular phone. Williams showed me the messages. The messages are from an unknown person. Three different phone numbers were used to make the threats. I copied a few portions of the messages. Williams is unable to be reached on her cell phone and will need to be emailed for contact.

- "Will Kill U", "Gonna kill you bitch" (1-11-2015)
- "Time to gangstalking bitch, Will kill you soon" (1-23-2015)
- "Will kill and rape Leslie Williams" (1-24-2015)

- a text mentioning Gang Stalking (12-22-2014)

Two pornographic photos of females, one on 12-27-2015 and the second on 12-30-2015.

BACKGROUND:

Williams has several email accounts, and also a couple youtube accounts. Williams can be heard under the user tag of ExposingSDPD1. Williams can be heard speaking about gang stalking.

STATEMENTS:

Statement of Leslie Williams:

Williams states she received several text messages. Williams states she feels threatened by the emails and the text messages. Williams says she always hears people walking by her talking about Gang
